 - c. When possible, choose accommodation that uses less wood or fuel-efficient firewood stoves.
 - d. You will help the rain forests by taking with you some soap and cleaning these on your back.
4. **Recycle paper & plastics in a safe place:** Recycle other waste paper and other recyclable materials including food tins back at your biodegradable if you come across other people's rubbish, remove their rubbish as well.
